Americans need smart policies that support a system that works for all of today's students. A system where educational providers and employers are connected, programs are flexible and support student success, and that all postsecondary learning is recognized.



## The higher education landscape is undergoing significant changes.

New delivery models such as competency-based and on-line education are now common. A wider range of providers are significant players in the field. American workers require education throughout their lives to advance their careers and adapt to the increasing pace of societal change. Thus, new kinds of credentials are emerging and must be recognized. Higher education is now only one piece of a more expansive post-secondary landscape.
